MSIP AND THE APR

The Missouri School Improvement Program (MSIP)

- Outlines expectations for school practices and student outcomes;
- Supports the statewide goal that each student graduates ready for success in college, career, and life; and
- Produces an APR for each local education agency (LEA) and building.



MSIP 6 STANDARDS & INDICATORS

Scored in the APR are:

- Six different strands ranging from leadership to standards, curriculum, and assessment.
- Individual standards within these strands are sorted into three main categories:
 - Performance
 - Continuous Improvement
 - Best Practice



PURPOSE OF THE APR

The APR indicates progress of Missouri students, schools, and LEAs toward standards adopted by the State Board of Education. It is:

- Produced for all school districts and charter LEAs
- Used in the process for classifying school districts
- Required for renewal decisions made by charter sponsors
- One of many ways that parents and communities evaluate LEAs

MSIP 6 APR - REFRESHER

What is a composite score?

- The APR Composite Score represents three years of APR data.

How is the APR Composite Score calculated?

- Points earned at the indicator level are summed and divided by three creating a three-year value for each indicator.
- Total points earned is a sum of three-year values for all indicators.
- The value for total points possible is calculated in the same way.
- The totals are used to calculate the APR Composite Score percentage.



ABOUT THE COMPOSITE

The 2025 APR data includes a composite score that includes data from 2023, 2024, and 2025. This information will serve as guidance for the upcoming classification of districts.

Classification Composite Score:

- Accredited with Distinction: 95% and above.
- Accredited: 70% to 94.9%
- Provisionally Accredited: 50% to 69.9%
- Unaccredited: 49.9% and below






COMPARATIVE APR ANALYSIS OF MISSOURI 4-DAY SCHOOLS

School districts that earned the same APR percentage are in alphabetical order.


PK-12 Top 10% Missouri 4-Day School Week Districts - Total APR Points Earned (2025)



Out of 155 PK-12 4-Day School Week Districts, Nodaway-Holt ties for #14 in Total APR Points Earned in the state; placing us in the top 9% in the state.



Overall Top 10% Missouri 4-Day School Week Districts - Total Points Earned (2025)



Out of 182 four-day school week districts (PK-12 or K-8), Nodaway-Holt tied for 19th in the state for total APR points earned; placing us in the top 10% in the state.



DISTRICT VS. STATE OVERALL

PERFORMANCE LEVEL 2025

CSIP Goal 1.1 - By 2026 students scoring in the bottom two categories of the MAP or EOC will decrease by 3-5%.

STATE RANKING

- Nodaway-Holt ranks 94th out of 553 school districts statewide (including private and charter schools) based on our 2025 APR percentage, placing us within the **top 17% of all Missouri districts**.
- Notably, thirteen districts are less than one percentage point away of our score, and two districts exceed us by only one percentage point.

CSIP Goal 1.4 - The average ACT composite scores for juniors and seniors will meet or exceed the state average on an annual basis.
